## VENUE RULES & REGULATIONS

- Day event times: 06h00 – 14h00
- Evening event times: 16h00 – 00h00
- Weddings / Full day event times: 09h00 – 00h00
- Please enquire with our events team should your event times fall out of these parameters.
- Supplier load out must take place straight after event unless otherwise arranged.
- Music must be turned down by 22h00 during weeknights and by 00h00 on weekends.
- No live bands or loud music will be allowed on a Sunday.
- The venue will be handed over clean – suppliers must remove all rubble and garbage from the venue.
- Post event cleaning fee over and above venue hire will be charged.
- Operations document with supplier details and load in and load out schedule need to be supplied to venue.
- No smoking in the venue – outside balcony only.
- The venue is supplied with furniture. It is the client's obligation to ensure furniture is placed back in their Original positions unless arrangements have been made with the venue – porters arranged.
- Please consider Hemelhuijs Restaurant during their operating times between 09h00 and 16h00 (Monday – Saturday).
- Parking: off street parking in Bree Street, Buitengracht Street & Riebeeck Street. Parking lot on the corner of Buitengracht & Waterkant Street (across the fan walk bridge) has 80 parking bays that is open to the public After hours and on weekends.
- Courtyard is off-- limits – you can drop off your equipment and then move the cars again. A maximum time of 10 minutes per vehicle is allowed. Loading zones are available in Waterkant Street, Buitengracht Street Bree street.  
Securing of these loading zones need to be arranged by the client through the City of Cape Town.
- Protect the lift – only smalls will be allowed in the lift. The lift is weight sensitive and you cannot hold the doors open with your hands / by placing something in front of it. Use the "hold open" button please.
- Use the emergency exit staircase (white stairs) to access the rooftop for bigger / heavy items.
- Toilets are available on the 1st floor. Wheelchair friendly bathroom on premises as well.
